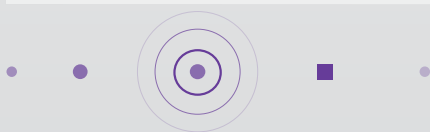
## THE CHALLENGE

Panaya has revolutionized Tremco's testing process by providing a centralized test repository that is easy to access and search. With Panaya, Tremco now has all tests in one place, making it easier to update tests when a process changes or to reuse them for new rounds of testing. Furthermore, the automatic test evidence meets audit requirements, and newly onboarded consultants and analysts worldwide have benefited from recorded test evidence to quickly familiarize themselves with existing processes. This has saved enormous amounts of time, leading to process improvement, efficiency gains, and better defect management.

The defect management system has been transformational for Tremco. It has provided developers with a more comprehensive understanding of the issues, thanks to the recorded evidence that is all in one place. This has saved testers from having to take screenshots and email developers. The system also prompts testers to add enough detail for developers to resolve issues, which has reduced the amount of back and forth. The comments track all updates, and notifications are sent when there is an update. The system-wide defect capability prevents testers from performing steps that are likely to fail. The resolution workflow of Open-Resolve-Close is user-friendly.

Tremco plans to continue using Panaya as its primary testing tool in the foreseeable future, mainly for regression and integration testing, evidence collection feature and the checklist it provides for specific processes. Looking into the future Tremco plans to explore using Panaya for testing other business-critical applications.
